- Transaction of shares by entity closely associated with directors -

Under the terms and for the purposes of the applicable legal and regulatory provisions, we hereby disclose the contents of the communication received from “TEIXEIRA DUARTE - Sociedade Gestora de Participações Sociais, S.A.”, reproduced here below:

In accordance with the provisions of the Commission Implementing Regulation (EU) 2016/523 of 10 March 2016, "Teixeira Duarte - Sociedade Gestora de Participações Sociais, S.A." (TDSGPS) it was, on 2nd of April 2019, a closely associated entity with the Directors of "Teixeira Duarte, S.A." Mr. Pedro Maria Calainho Teixeira Duarte and Mr. Manuel Maria Calainho de Azevedo Teixeira Duarte since these were, at that date, also Directors of TDSGPS itself.

In light of the foregoing, it is in compliance with those regulations, with number 1 of Article 248-B of the “Código de Valores Mobiliários” and with other applicable laws that TDSGPS hereby informs that, on 2nd of April 2019, it has entered into an exchange of shares, through which it sold, under a prior resolution taken pursuant to the Law and the Bylaws, 10,000 own shares to " MIDINVEST - Gestão e Investimentos, Sociedade Unipessoal Lda." (MIDINVEST), and acquired, in exchange, 350,000 shares representing the capital stock of "Teixeira Duarte, S.A.".

The acquisition of the 350,000 shares of "Teixeira Duarte, S.A." by TDSGPS is reported to you under the terms of the "template for notification and public disclosure of transactions by persons discharging managerial responsibilities and persons closely associated with them", drawn up in accordance with Commission Implementing Regulation (EU) 2016/523 of 10 March 2016, attached hereto.

We further inform that, after the aforementioned exchange operation, TDSGPS had held, on the 2nd of April 2019, of 202,831,978 shares of "Teixeira Duarte, S.A.".
