PROPOSAL PRESENTED WITHIN THE SCOPE OF
THE FIRST ITEM OF THE AGENDA

As regards the matters included in the First Item of the Agenda of this General Shareholders' Meeting, shareholder "Teixeira Duarte 1886, S.A." proposes the following:

1. Approval of the Consolidated Management Report, which includes a chapter on non-financial information and the Accounts, individual and consolidated, of the 2023 financial year;
2. Approval of the Corporate Governance Report which includes the report on remunerations of the managing and supervisory bodies of the company, both regarding the 2023 financial year.
